

# How to List a Stallion for Breeding

### Stallion Listing

- ◆ Listing a stallion serves the purpose of declaring your intent to breed him. Whether your stallion is a registered American Paint Horse, a Quarter Horse or a Thoroughbred, there is a \$75 stallion listing fee due when the first stallion breeding report is filed. This a one-time fee to list a stallion as an eligible sire for his lifetime.
- ◆ The recorded owner of the stallion must sign this form.
- ◆ Any other signatures placed on the this form will be accepted as authorized agent(s) to sign stallion breeding reports, breeder's certificates and semen transport permits for the specified stallion on behalf of the record owner.
- ◆ If the stallion is a Quarter Horse or Thoroughbred, a copy of the front and back of the AQHA or Jockey Club registration certificate showing the recorded owner at the time of breeding and the pedigree/bloodlines is required.
- ◆ Should you sell the stallion, the new owner will need to refile the listing card (at no additional charge) and submit current photocopies of the stallion's registration certificate showing the change in ownership.
- ◆ If the stallion is an American Paint Horse, a copy of the registration certificate is not necessary.

### Other Items Necessary When Breeding a Stallion

- ◆ **Stallion Breeding Report**—You must submit a Stallion Breeding Report each year you breed the stallion. Stallion breeding reports are due on or before November 30 of the breeding year. Postal meters are not accepted. You may file your Stallion Breeding Report on line at [apha.com](http://apha.com), or request forms by contacting the General Information Department at (817) 834-2742, extension 788.
- ◆ **DNA Genetic Testing**—All breeding stallions must be DNA genetic tested. To request a DNA genetic test kit for your stallion, contact the APHA Field Services Department. If a stallion's DNA genetic markers are already on file with an APHA-approved laboratory, it may not be required again if the owner of record provides APHA with a copy of the genetic markers.
- ◆ APHA rules require accurate and timely completion of stallion listing cards, Stallion Breeding Reports and DNA genetic test information (see rule GR-060.A).

### Membership

- ◆ If you do not have a current membership with the Association and wish to take advantage of member rates, you may purchase a membership at this time. Membership rates will then apply to this transaction and any others postmarked during the membership period. Memberships will consist of a 12-month period beginning in the same month as the request for listing is postmarked. Multiple year memberships are available.
